REGIONAL OFFICER INSTITUTES

This new program for chapter and colony officers will have five tracks to help each officer better understand his roles and responsibilities within the chapter. The development of these programs is based off feedback from undergraduates over the past three years and their involvement at programs like Dover Days and International Convention and last year's Officer Pilots.

You are required to send four of the following positions (covered by your Fall program fee), although we highly encourage that you send all six of the positions or their equivalent roles: President, Recruitment Director, Operations Director, Brotherhood Development Director, Standards Director and Finance Director. If your campus is more than 350 miles away from your closest regional officer institute, you are only required to send two delegates, but are still welcome to send four at no additional fee.

The programs will take place in the following cities:

October 5-6, 2018, Chicago, IL
October 12-13, 2018, Philadelphia, PA
October 19-20, Boston, MA
February 8-9, 2019, Los Angeles, CA
February 22-23, 2019, Orlando, FL

As with past regional programs, the registration, the registration deadline for these programs will be two weeks in advance of the program.
